Updated Property Tax Information Now Available for Texas Taxpayers

Woodville — New and updated property tax information has just been compiled by the Tyler County Appraisal District and is available now to assist taxpayers. This property tax information is current and covers a wide range of topics, such as taxpayer remedies, exemptions and appraisals, and has information for select groups, such as disabled veterans and persons age 65 or older.

“Whether you are a homeowner, business owner, disabled veteran or taxpayer, it’s important you know your rights concerning the property tax laws.” said David Luther, Chief Appraiser of the Tyler County Appraisal District.

“You can contact us about any property tax issues with full confidence that we will provide you the most complete, accurate and up-to-date available information to assist you.”

This includes information about the following programs.

- **Property Tax Exemptions for Disabled Veterans** - The law provides partial exemptions for any property owned by veterans who are disabled, surviving spouses and surviving children of deceased disabled veterans. This includes homesteads donated to disabled veterans by charitable organizations at no cost to the disabled veterans and their surviving spouses. The exemption amount is determined according to percentage of service-connected disability. The law also provides a 100 percent homestead exemption for 100 percent disabled veterans and their surviving spouses and for surviving spouses of U.S. armed service members killed in action.
- **Property Tax Exemptions – Non-profit organizations** that meet statutory requirements may seek property tax exemptions and must apply to their county appraisal district by a specific date. There are a number of industrial exemptions for unique exemption. More information is available at the appraisal district.
- **Rendering Taxable Business Personal Property** - If a business owns tangible personal property that is used to produce income, the business must file a rendition with its local county appraisal district by a specified date. Personal property includes inventory and equipment used by a business. Owners do not have to render exempt property such as church property or an agriculture producer’s equipment used for farming.
- **Appraisal Notices** – Some taxpayers will receive a notice of appraised value this year, especially for properties within the boundaries of the Woodville school district including the City of Woodville and the City of Ivanhoe. The city, county, school districts and other local taxing units will use the appraisal district’s value to set property taxes for the coming year.

- "*Property Taxpayer Remedies*" – This Comptroller publication explains in detail how to protest a property appraisal, what issues the county appraisal review board (ARB) can consider and what to expect during a protest hearing. The publication also discusses the options of taking a taxpayer's case to district court, the State Office of Administrative Hearings or binding arbitration if the taxpayer is dissatisfied with the outcome of the ARB hearing.
- Homestead Exemptions – A homestead is generally defined as the home and land used as the owner's principal residence on Jan. 1 of the tax year. A homestead exemption reduces the appraised value of the home and, as a result, lowers property taxes. Applications are submitted to the appraisal district.
- Productivity Appraisal – Property owners who use land for timber land production, agricultural purposes or wildlife management can be granted property tax relief on their land. They should apply at the appraisal district.
- Residence Homestead Tax Deferral - Texas homeowners may postpone paying the currently delinquent property taxes due on the appreciating value of their homes by filing a tax deferral affidavit at the appraisal district. Please call the appraisal district for further explanation.

This tax relief allows homeowners to pay the property taxes on 105 percent of the preceding year's appraised value of their homestead, plus the taxes on any new improvements to the homestead. The remaining taxes are postponed, but not cancelled, with interest accruing at 8 percent per year.

- Property Tax Deferral for Persons Age 65 or Older or Disabled Homeowners – Texans who are age 65 or older or disabled, as defined by law, may postpone paying current and delinquent property taxes on their homes by signing a tax deferral affidavit. Once the affidavit is on file, taxes are deferred, but not cancelled, as long as the owner continues to own and live in the home.

Interest continues to accrue on unpaid taxes. You may obtain a deferral affidavit at the appraisal district.

- Notice of Availability of Electronic Communication – There are very limited communication services available on the appraisal district website. Written agreements are required for notices and other documents to be delivered electronically instead of mailing.
- Protesting Property Appraisal Values – Property owners who disagree with the appraisal district's appraisal of their property for local taxes or for any other action that adversely affects them may protest their property value to the appraisal district's ARB.
